#### **Message from the Executive Director**



## Introduction & Background

With the potential leadership of former United Nations Volunteer (UNDP, Nepal) A H M Faisal Ahmed SJA has been developed as a locally based, not-for-profit and non-political development organisation that would operate at a "grassroots" level to address the real needs of economically and socially marginalized members of the community in Sylhet.

Initially, the organisation specialised in youth training projects in order to develop young people's skills and thereby their economic prospects. Since then, SJA has expanded into a respected and innovative organisation, covering up to 1.48 million people in the Sylhet, Chittagong & Dhaka division. The organization now focuses its efforts on combating diseases like STI and HIV/ AIDS, malnutrition, social wounds like poverty, illiteracy, unemployment and issues like disability, health and family planning, environment and climate change, water resource management, water and sanitation, infrastructural development, sexual and reproductive health & rights, gender sensitization, human rights protection and stop violence against women and children.

## Disability Rights & Development

SJA has been implementing "Removing Cultural Barriers (RCB) Project" with the financial support of Murant Fund & Roper Fund and the technical support of Action Aid Bangladesh since 2014 with a SMART objectives to Improve government-run teacher training programs to make education inclusive for children with disabilities, equip young people with disabilities with the skills, knowledge and access to pursue opportunities to earn a living and improve the quality of care provided by carers for children and young people with disabilities in Bangladesh. In 2015, SJA implemented different activities for developing life standard of Child and youth people with disabilities by ensuring their rights according to the "Disability Rights & Protection Act 2013", self and wage employment, health and rehabilitation. SJA gain acceptance in the community as well as in the project area through involving a total of 150 children & 150 youth with disabilities and their families in 2015. SJA was able to implement different programs successfully in the project area in order to create mass awareness regarding disability and disability rights protection issues. Through this program, SJA gained well acceptance in the community as well as in the Government sectors and emerged itself as a pioneer of disability sector. This project has two different sections: Removing Cultural Barriers and Health & Rehabilitation.

## Removing Cultural Barriers: Objectives:

1. Improve government-run teacher training programs to make education inclusive for children with disabilities. (PP-1)

2. Equip young people with disabilities with the skills, knowledge and access to pursue opportunities to earn a living. (PP-1)



#### Learning:

- It is necessary to work more and more with the parents of Youth and children with disabilities for the development of their life and to ensure their rights and build up awareness of YPWDs guardian on self and wage employment.
- It is necessary to go with the implementation plan and guide line or capacity building training for project staff before starting any activity.
- Arrangement of meetings with Upazila level Education Committee and Disability Rights Protection Committee is much more depends on the committee formation.
- Availability of Govt. Authorities in different committee meetings.

#### Challenges:

- 1. Meeting organizing with Govt. Authorities is very difficult due to excessive busyness of GoB authorities and their prioritization.
- 2. The stakeholders of RCB project are very poor and needy. Therefore, it becomes hard for SJA to fulfill the demand and help them in getting their rights.
- 3. YPWDs live in the different areas of the union level. Therefore monthly meeting conduction of Self Help Group is very difficult.

#### Success Story:

19 years old Ali Hossain son of Mr. Abdul Miah lives in Uttarbagh village, Fulbari Union of Golapgong. He is from a very poor family. He is a person with physical disability. SJA has conducted a survey through which he has been identified. His father is a CNG driver and mother is a house wife. Due to poor economic condition of his family his father could not able to involve him any business activities. Rather for his physical condition he could not involved himself any job or other income generating activities. As he was unemployed therefore he cannot contribute financially in his family.

SJA RCB project listed Ali Hossain in self employment category. He is a member of Surjomuki self help group at Baga Union and member of Jubo protibondhi kallayan somitte (CBO) Golapgonj. Ali Hossain received Ioan amount of taka 12,000.00 (Twelve thousand) from Jubo protibondhi kallayan somitte (CBO) Golapgonj for starting a small business. He has started his small business from last month in pachmail Bazar, golapgonj. Now he is very happy to earn money and able to contribute in his family. His parents is also very happy to see this change and very much thankful to SJA RCB project.



## Gender & Human Rights

Women are deprived of their rights in the society and the DV is an unrecognized offence. To address Human Rights especially Domestic Violence (DV) issues at community and family level, SJA has been implementing Protecting Human Rights (PHR) project at the five unions of Balagonj Upazila under Sylhet District. The PHR is one of the most important projects in response to establishing equal gender access and to end VAW at community & family level. With the assistance of Plan International Bangladesh the project become operational from May 2012.

#### Goal:

Reduce the high prevalence of domestic violence and other related human rights violations in Bangladesh.

#### **Project Objectives:**

- Conduct advocacy for adoption and enforcement of key Domestic Violence (DV) and Human Rights (HR) legislation and policies.
- Improve mutual understanding and effectiveness among key factors involved in combating DV and strengthening other interwoven HR issues.
- Increase willingness of survivors to seek and access to justice through formal and informal justice system.
- Expand immediate and longer supports to survivors of DV.
- Raise awareness on DV and related HR issues at national and local levels.





#### Component 1- Advocacy:

Enhance advocacy efforts of civil society organizations and coalitions to support the adoption and enforcement of laws and policies that prevent domestic violence and associated human rights abuses against women, children and other vulnerable groups.

#### Component 2- Capacity Building:

Strengthen the capacity of key actors to investigate and monitor domestic violence and other human rights violations and enable the survivors to combat domestic issues.

#### Component 3- Access to Justice:

Increase access to justice for abused women and other vulnerable groups through informal and formal mechanisms, including Alternative Dispute Regulation (ARD).

#### Component 4- Survivors Services:

Provide support for survivors' services of domestic violence and other human rights abuses. PHR will provide support to local non-government organizations to strengthen, expand and sustain social service.

#### Component 5- Mass Awareness and Educational Campaign:

Expand public awareness and implement an educational campaign to increase understanding of human rights, with particular emphasis on the impact of domestic violence.

#### Case Story of Safera Khatun

Safera Khatun is the only daughter of Showkat Miah and Pori Begum. They live in Tahar Bohor village of Gouripur Union under Balagonj Upazila. Safera is a student of class-X and she is only 15 years old. Safera has been leading her life with her little and immature life. Suddenly a storm came into her life with her marriage offer from a foreigner (Londoni). Her parents cannot control their greed and they become ready to give Safera marriage to this foreigner. But Safera did not want to get married. She wanted to go for further study.

But her parents did not paid any head to their daughter. One day Safera met with the social worker of SJA PHR project and told her everything. The social worker tried to protect her from early marriage by talking to her parents. But Safera's parents did not listen to her. Then the social worker went to the Police Station and with the help of Law Enforcing Agency the social worker of SJA PHR project protected the under aged Safera from marriage.

Safera is now continuing her study and right now she has completed her school and admitted in to college.



#### STI & HIV/AIDS Awareness and Prevention

Under GFATM 908 package associate of BWHC consortium Sylhet Jubo Academy (SJA) started a journey since March 2008 to achieve the goal means reduce risk of HIV-AIDS among the high risk population and vulnerable young people in our country by "Provision of Essential Services to Street Based and Hotel/Residence Based Female Sex Workers in selected district of Bangladesh" with the financial support of GFATM/Save the Children-USA. SJA has started provision essential services to the targeted intervention with the previous vast experience on it since March 2008 through DIC implementation. Project activities implemented through 8 DICs and 1 Outlet which are situated in the different district of Sylhet Division. These are Shahjalal Upashahar, Badambagicha, Akhalia (outlet) and Jaflong (Guainghat upazila) of Sylhet district, Hobigonj sadar upazila of Hobigonj district, Moulovibazar sadar upazila of Moulovibazar district, Chattak and Sadar upazila of Sunamgonj district.

#### Key Accomplishments over the Reporting Year:

SJA has been working with 2088 Female Sex Worker through 7 DIC and 1 Outlet in Sylhet division. Among them Street based are 340, Hotel based are 144 and Residence based are 1604. To prevent HIV/AIDS and ensure safer sex SJA provided different services to them so that they can enjoy better quality of life. SJA are trying to create an environment which support them positively to enjoy their rights and entitlements. SJA has an initiative of different life-skill training to create employment opportunities of FSWs.

### Challenges:

It is hard to manage eligible house for office rent with in this budget limit and irregular payment so it is necessary to increase budget for house rent and ensure regular payment.

- Reach the target of Condom Social Marketing is difficult because different NGOs including Govt. provide free of cost condom at the same area.
- Front line staff especially Support Staff drop-out due to limited/inadequate remuneration so for staff sustain .it may increase salary at present context.
- Inadequate budget for standard decoration/arrangement of the recreation room, replacement of games equipment so need to increase budget to meet up the requirement as per DIC.
- Inadequate medicine and IP materials to maintain standard of STI treatment.
- It is hard to get local level legal service providers who are eligible to provide legal service for the FSWs.
- Difficult to done planned activities on time due to irregular fund flow, need to special attention for regular fund flow.
- Sometimes hampered especially outreach activities due to inadequate and irregular condom supply, take necessary attention for regular and timely supply of need based condom.
- It is difficult to arrange DAC meeting through this limited budget, if possible may increase budget.
- Very few opportunities to make awareness mass people against stigma about SW and DIC staff through ongoing project activities, it may arrange mass gathering about project activities so that people can be able to realize about SWs rights and entitlements.

#### **Lesson Learned:**

During implementation of the project some lessons have been learned. On the other hand some problems/ issues are coming in to focus. These lessons/findings will help us to think about a new or changed strategy, which will help immensely in implementing this type of projects in future:

- Low salary limit is the main cause of staff-drop out which is not enough at present context of Bangladesh.
- It is much more effective to disseminate information about HIV/AIDS through folksong/ street show/film show etc to the mass people at a time.
- Irregular fund flow frustrated and demoralize staffs as a result reduce quality of services and staff productivity.
- 6day duration for IGA training such Tailoring, Nakshikathan is not enough, so they could not able to adequate skill for producing quality products.
- Some SWs want to change their current occupation and back to the mainstreaming if they have alternative scope of income.
- For appropriate track of the planned activities and to update the trend of the project progress, it is important to technical analysis and quality determination of day to day data collection from field. Contrarily, the challenges of the project and lesson learned at field needs to share on regular basis which will help other help to avoid similar challenge/ mistake. To do all those activities, organization felt necessity of a technical person on data analysis, reporting and sharing.
- Targeted community might be more empowered and interactive through SHG. To do that they need extensive capacity building support. So, provision of more training, network with different alliance, CBOs, legal organiza tion is important for empowering this target group.
- Monitoring and Evaluation, Training, Reporting, Coordination and other related many activities properly done
  are essential. But only Coordinator maintains these activities. So, additional supporting staff for partner would
  definitely strengthen qualitative activities.
- Night field is difficult for implementing outreach activities for hotel and residence. Because hotels are involve
  with illegal business. On the other hand residence based sex workers are usually live in the mainstream
  people. Both hotel and residence maintain confidentiality. For this in the night they do not allow easy access
  of NGO staffs.

SJA has started provision essential services to the targeted intervention with the previous vast experience on it since December 2009 through DIC implementation. Project activities implemented through 8 DICs in the different district of Chittagong Division. These are Chittagong, Cox's bazar, Khagrachari, Rangamati, Bandarban under Chittagong Division.

#### "Case Study"

**Introduction:** Case Study is a very important element of a project. Case Study measure the achievement of the project goal and the life standard of the targeted population can be known through it. This case study is based on a real story which has been collected by the Peer Educator. The said documentation has been made to illustrate the success of Link Up Project.

**Background Information:** SJA was established in August 1991 by a small group of philanthropists, led by former United Nations volunteer, A H M Faisal Ahmed. Their aim was to develop a locally based, not-for-profit and non-political development organization that would operate at a "grassroots" level to address the real needs of economically and socially marginalized members of the community in Sylhet.

Initially, the organization specialized in youth training projects in order to develop young people's skills and thereby their economic prospects. Since then, SJA has expanded into a respected and innovative organization, covering up to 1.42 million people in the Sylhet, Chittagong & Dhaka division. The organization now focuses its efforts on combating diseases like STI and HIV/ AIDS, malnutrition, social wounds like poverty, illiteracy, unemployment and issues like disability, health and family planning, environment and climate change, water resource management, water and sanitation, gender sensitization and stop violence against women and children.

Since its inception, SJA has been working for the disadvantage community especially women and children for ensuring their rights of education, health as well as increasing awareness. As a continuation of this, SJA has been implementing "Link Up" program in Sylhet and Chittagong Division with the financial and technical support of HASAB for ensuring "Sexual and Reproductive Health & Rights (SRHR)". The targeted population of this project is 4,000 FSW in Sylhet and 20,000 pavement dwellers in Chittagong.

#### Problem:

My name is Poly (pseudo name) and I am 19 years of old. I live in Sunamgonj. We have had a very big family of 09 members and my family condition was very poor. My father mother is day labourer. It was very hard for my parents to run the family expenses with their little income. I was very agile from my childhood. Considering our poor family condition my mother searched a house for me to work there as a house assistant (Bua). At first, I felt boring but then I accept this. Everybody loved me a lot. Suddenly I fallen love with a relative of the house owner. He always gives me good advice. I usually very much fond of him and trust him a lot. One day he asked me for a long drive. I agreed with him and took a leave from my job. He took me to Sylhet. We enjoyed a lot there and it took so much time and turned to night. Then I and Matin (My beloved) took shelter in a hotel by disguising us as husband and wife. Then we came close to each other and involved in sex. The next day went to Sunamgonj and the family members started doubting me. After dinner the elder son of the house owner asked me about yesterday. I was so scared. He told me not be afraid and requested me to tell the truth. He also gave me hope not to discuss this to anybody. I felt him trustworthy and told him everything. After hearing the truth he told me to give him time (involve in sex with him) or otherwise he will tell everybody. He broke his promise and forced me to do so. Then I discussed this to Matin. He told me to do sex with the elder son of the house owner. After some time I have got married with Matin and he took me to Dhaka. Then he took me to a hotel and told me to stay there. After sometimes two men came to my room told me to go with them. I asked them about their identity and where to go. They told me that they are the friends of Matin and they are here to take me to Matin. Then they took me to a house but Matin was not there. Then they did sex with me by force and tortured me differently. I was become unconscious. Then they left me in unknown place. I was so much afraid and found no place to go. I remain foodless until two days. Then I came to Farmgate and took the job in a hotel as a maid. One day the manager told me to do sex to earn more money. Then he introduced me with another maid of this hotel. She told me that if I disobey the manager than he will not let me to do work there. After that I have become a professional sex worker. After two weeks I came back to Sylhet. I took a small rented house and start sex work at residence and hotel. Once a woman came and told me that she is from Link Up project which implemented by SJA. Then she told me that she is also a sex worker and gave some information regarding the issue of maternal health and Sexual and reproductive health and rights. Then she request to share my any problem to her as she is like me. I told her about my physical condition. She told me that I can get any kind of health services from SJA Link Up Point and from Marie Stopes Bangladesh clinic at free of cost. Through her message I came to learn that heath service and any kind of services getting is my right. I have become sensitized about my rights and went to Link Up Point for health services. I have got as good services from Lin k up point. After that I took part in different session. I have learnt many things from the sessions. Now whenever I got time I tried to provide different information to my fellow mates.


I think these kinds of messages are very important for us and hope this Link Up project will continue and we will get better services.

**Project Completion Summary:** 

Sylhet Jubo Academy (SJA) has completed installation of 02 Water Wells and 50 Hand Tube Wells within the project duration with spontaneous active participation of local government and community. The project locations are Jalapur Union of South Surma Upazila, Jaflong Union of Gowainghat Upazila and Golapgonj Sadar, Fulbari, Dhaka Dhashin, Poschim Amura Unions and Paurashava of Golapgonj Upazila of Sylhet District and Paindang Union of Fotikchori Upazila of Chittagonj Dsitrict under Sylhet and Chittagong Divisions, Bangladesh. SJA has installed Water Wells at Jalapur Union of South Surma Upazila, Jaflong Union of Gowainghat Upazila and Golapgonj Sadar, Fulbari, Dhaka Dhashin, Poschim Amura Unions and Paurashava of Golapgonj Upazila of Sylhet District and Paindang Union of Fotikchori Upazila of Chittagonj Dsitrict under Sylhet and Chittagong Division of Bangladesh. During installation, Upazila Nirbahi Officer of respective upazilas was present at the Installation Inaugural Sessions. On the other hand native UP Chairmen has visited the boring spots during installation. SJA has ensured Water Testing of all the 52 water points through Upazila Department of Public Health and Engineering (DPHE) and set up NAME PLATE in the Platforms for each tube well. After water testing SJA ensured colour of all the tube wells with GREEN colour paints. Total number of 5560 beneficiaries households directly benefited by the implemented water sources.

SJA also believe in linkage & networking and for that SJA build up linkage with GOB and other development like minded organization in order to ensure proper human development and establish a society free from poverty, hunger and all forms of discrimination. Currently, SJA has been implementing 2 programs with the GoB wings Sylhet Metropolitan Police and Ministry of Women and Children Affairs. The descriptions of two programs have been given below:

#### Police Reforming Project:

SJA has been implementing this project with Sylhet Metropolitan Police where SJA is providing Psychosocial counseling to the victims of domestic violence and other victims especially women. SJA is providing these services under the agreements between SJA and Sylhet Metropolitan Police.



SJA has been implementing this project to achieve the following objectives: To improve the quality of services provided to female victims of violence in relation to health, Police assistance, criminal justice, counseling and social assistance, improve women's access to the legal justice system, create general awareness of the issues of crimes and violence against women. The activities performed by SJA under this project are provide psychosocial counseling to the victims of domestic violence, sexual abuse, harassments and others in One Stop Crisis Center of Sylhet MAG Osmani Medical College.





## A Few Additional and Alliance Building Activities of SJA with its own Contribution

#### Deaf in Literacy and Rights Academy DILARA):

SJA has gained long experience in working with disable people in Sylhet region. From its inception, SJA always tried heart and soul to help the disable people. The project DILARA funded by ABILIS Foundation and SJA has implemented from January'2009 to December'2009 in two Upazilas of Sylhet District to improve the livelihood status of deaf children through providing non-formal functioning education and Bangla sign language support, targeting to enrolment of the deaf children to the mainstreaming school in locality and to promote empowerment, participation and inclusion by creating greater awareness, increasing use of Bangla sign language and strengthening capacity of their parents career as change agents.

Though the duration of the project has completed, SJA still implementing this project for the sake of people with disabilities by its own contribution and initiatives. SJA is working for the better improvement of the livelihood status of deaf children by providing different support and mainstreaming them.

#### Bangladesh Shishu Adhikar Forum (BSAF):

SJA as member of different forums and consortiums, performing its role very successfully. BSAF is a reputed forum which is working for the rights of the children and SJA is a member of this forum. In 2014, under this forum SJA organized various events like advocacy meeting, round table discussion with civil society, GO-NGO representatives etc.
